

## ELECTION "PHOTO ID REQUIREMENT" FOR 2016 ELECTION YEAR

In order to receive a ballot for all future elections, voters will be required to show a valid photo ID.

A current Wisconsin driver's license is acceptable, which will work for most folks. For those

that don't have that, there are other forms of acceptable photo ID -- check out [www.bringit.wi.gov](http://www.bringit.wi.gov) for the specifics.

The first election is February 16, with the next election (which includes the U.S. Presidential primary) on April 5.

**We encourage everyone to make sure they have a valid photo ID well in advance of election day!**
